# Types of Planned Gifts

#### Wills and Living Trusts

A charitable bequest through your will or estate is the easiest way to make a planned gift. Providing for Food Gatherers through your will or trust won't cost you a penny in your lifetime, and you retain complete control over your assets.

This type of planned gift provides the flexibility to easily change your donation in the event that life circumstances change.

Including Food Gatherers in your will and/or trust is as easy as adding the following language:

"I give, devise, and bequeath <u>[percent of estate or dollar fixed amount]</u> to Food Gatherers (Tax ID Number: 38-2853858). Food Gatherers is located at 1 Carrot Way, Ann Arbor, MI 48105."

### **Beneficiary Designations**

You can name Food Gatherers as a beneficiary in:

- IRAs and retirement plans
- · Life insurance policies
- Donor advised funds
- · Commercial annuities

To add Food Gatherers as a beneficiary, start by requesting a change-of-beneficiary form from your policy administrator. Make your desired changes and return the form to establish your gift.

#### Charitable Gift Annuities

There is a way for you to support Food Gatherers and feel confident that you have dependable income in your retirement years. With a charitable gift annuity, you agree to make a gift to Food Gatherers and we, in return, agree to pay you (and someone else, if you choose) a fixed amount each year for the rest of your life. The balance is used to support our work. Feeding America offers a program assisting with these planned gifts.

While these are popular types of planned gifts, there are other options that may better suit your needs. Please consult with a financial planner or attorney when considering a planned gift.
