Essential Duties and Responsibilities

- Picks up and delivers food safely to/from locations throughout Washtenaw County
- Provides excellent customer service to donors, volunteers, and partner agency representatives.
- Ensures that food is maintained in proper condition and at proper temperatures.
- Uses safe work practices during the receiving and delivery processes.
- Segregates and disposes of unsafe or non-usable food.
- Performs warehouse duties such as product prep and staging
- Records required data such as temperatures, food weight, vehicle inspection data, and cleaning/maintenance logs accurately and in a timely fashion.
- Responsible for safe operation, loading, and unloading of company vehicles.
- Communicates proactively with the Food Run Manager regarding daily activities and suggestions for process improvements.
- Provides training to volunteers and co-workers as required.
- Follows established warehouse and documentation procedures for product receipt, handling and rotation.
- Complies with the organization's policies and procedures, safety requirements, quality standards, and applicable local, State, and Federal laws, traffic regulations, and industry guidelines.
- Performs other related duties and responsibilities as needed and assigned.

- Previous work experience in transportation, food service or warehousing is preferred, but not required
- Must be able to pass a DOT physical examination and obtain a Michigan Chauffeur License upon hire

Some work takes place in a warehouse environment; this may include working around machines with moving parts, moving objects, and/or radiant and electrical energy; working closely with others. The Food Runner/Driver will spend a significant portion of their work hours outdoors.
